Scholarship America's decisions are based solely on the information you provide. Be sure to completely answer each question and include all extracurriculars, special recognitions, and personal or family circumstances.


## Notification

Applicants are notified in **early July**. The number of awards depends on available funds.

Students who meet eligibility may **reapply each year**.

## Scholarship Payment

Checks will be disbursed and made payable to the schools in mid-August.



## Confidentiality


## To PFIA Members:

## About the PFIA Scholarship Program

Established in 1987, the **Police and Firemen's Insurance Association Scholarship Program** was created to encourage and support higher education.

Recipients are selected based on:

- Academic performance
- Demonstrated leadership and participation in school and community activities
- Honors and achievements
- Work experience
- Career and educational goals
- Unusual personal or family circumstances

The program is administered by **Scholarship America**, the nation's largest designer and manager of scholarships for corporations, foundations, and associations.

Awards are granted without regard to race, color, creed, religion, sexual orientation, gender, disability, or national origin.



## Eligibility Requirements

Dependent children\*, stepchildren, grandchildren, or great-grandchildren of PFIA members in good standing.

Member's insurance policy must be in effect for at least six months as of **May 1**.

Applicant must also hold a legal reserve insurance policy with PFIA.

Must be enrolled or planning to enroll as a **full-time undergraduate student** at an accredited two- or four-year college, university, or vocational-technical school.

Must meet all other PFIA Scholarship Program criteria as of **May 1**.

\* **Dependent children** are defined as natural or legally adopted children or stepchildren living in the member's household or primarily supported by the member.

\*\* **Full-time** means full-time enrollment for the entire upcoming academic year.

## Scholarship Awards

**\$1,500 per year** for full-time undergraduate study.

Renewable for up to **three years** with a cumulative GPA of **2.5 or higher**.

Both the member's and recipient's policies must remain active during the award period.

Awards apply to **undergraduate tuition and fees only**.
